Vending at the boogie is a 2 1/2 day event. All food and craft vendors welcome.

Saturday 12:00-10:00pm

Sunday 11:00am-5:00pm

*Now for the fine print...*

Friday set up 10:00am-4:00pm (no later please) We will be on the grounds all day.

**NO Saturday set up, Friday only.**

Please leave security fence in place. If you need to go through the fence to set up, please put it back once you are set up. Thank you.

No more than two people may work vending spot without tickets.

Vendors are responsible to get all garbage created at their spot to the dumpster.

A \$50.00 deposit will be required of all vendors returned upon inspection at the end of the weekend.

**Please fill out vendor application, and mail with half of vendors fee plus \$50.00 deposit.  
Remainder of fee due day of show. Applications are due June 1st.**

## Vendor Guidelines

### **VENDORS MUST PROVIDE**

- Tables & chairs (if needed)
- Trash cans (2 minimum)
- Lighting (lights, extensions cords etc, electricity is provided)
- Tent (tents can be provided for an additional fee)

Vendor deposits are non-refundable for cancellation.

Vendor fees are non-refundable for cancellation after August 6.

All food service vendors must provide their own water and sanitary facilities to provide clean, healthy conditions for the public and at least two trash cans for their area.

Vendors are responsible for their site conditions. All vendors **MUST** clean their area and deposit ALL trash in trash containers. A \$50.00 deposit is required which will be returned after the event and upon inspection.

Vendors must remain at the festival for the entire duration unless permission to leave early is granted by the promoter.

**MEALS & RENTALS LICENSE** – If you intend to sell food, beverages and/or tobacco products, please contact the NH Department of Revenue Administration to determine if you are required to report your sales and register at (603) 271-2191 or visit [www.revenue.nh.gov](http://www.revenue.nh.gov).
