No more than two people, work vending spot with out tickets.

Vendors are responsible to get all garbage created at their spot to dumpster. A \$50.00 dollar (clean up) deposit will be required of all vendors returned upon inspection at the end of the weekend.

Please fill out vendor application, Deposit for 1/2 of vendors fee plus \$50.00 dollar (clean up) deposit. Make check out to Benton's Sugar Shack. Remainder of fee due Day of show. **Application's due June 1st**

- Lighting (lights, extensions cords etc, electricity is provided)
- Tent (tents can be provided for an additional fee)

All vendors must show up and set up on the morning of the scheduled event.
All vendor fees are non-refundable for cancellation prior to 15 days before day of event.

All food service vendors must provide their own water and sanitary facilities to provide clean, healthy conditions for the public and at least two trash cans for their area.

Vendors are responsible for their site conditions. All vendors **MUST** clean their area and deposit ALL trash in trash containers. A \$50.00 deposit may be required which will be returned after the event and upon inspection.

MEALS & RENTALS LICENSE – If you intend to sell food, beverages and /or tobacco products, please contact the NH Department of Revenue Administration to determine if you are required to report your sales and register at (603) 271-2191 or visit www.revenue.nh.gov.
