Additional Guidelines

- All Vendor employees must have a Vendor landyard, and wear it at all times.
- At the end of the festival, please remove all trash and bring it to the dumpster. Please do not leave your trash in front of your site.
- All food service vendors must provide their own water and sanitary facilities to provide clean, healthy conditions for the public. We will provide trash cans.
- Vendors must remain at the festival for the entire duration unless permission to leave early is granted by the promoter.
