- All Vendor employees must have a Vendor lanyard, and wear it at all times.

- All food service vendors must provide their own water and sanitary facilities to provide clean, healthy conditions for the public. We will provide trash cans.
- Vendors must remain at the festival for the entire duration unless permission to leave early is granted by the promoter.
